Anne Carlsen Center for Children, Jamestown, ND, **\$100,000**. To construct a new residential facility to better meet the needs of disabled children and their families.

North Dakota Center for Nursing, Fargo, ND, **\$15,000**. For development of a high school outreach program to address a nursing workforce shortage in North Dakota, particularly in rural areas and reservations.

North Dakota Council on Abused Women's Services, Bismarck, ND, **\$150,000**. To fund the work of FUSE and the North Dakota Human Trafficking Task Force to continue providing comprehensive services to victims and proactive investigations of human trafficking.
