Otto Bremer Trust awards \$28.4 million in 34 grants

SAINT PAUL, May 20, 2025 — The Otto Bremer Trust awarded \$28,434,750 in grants in the first four months of 2025. Of that amount, \$16,800,000 was awarded to the seven intermediary organizations administering the 2025 OBT Community Responsive Fund.

"These grants demonstrate our ongoing commitment to strengthening communities throughout the region," said Daniel Reardon, co-CEO and trustee of OBT. "The seven Community Responsive Fund grants enable OBT to utilize the knowledge and trust of local, regional, and statewide organizations to further our mission."

State totals for grants awarded include:

- Minnesota: \$14,430,650
- Montana: \$2,525,000
- North Dakota: \$2,850,000
- Wisconsin: \$8,629,100
