Otto Bremer Trust awards \$17.4 million in grants

SAINT PAUL, January 15, 2026 — The Otto Bremer Trust awarded \$17,415,000 in grants in November and December 2025.

"From economic development to health services to meeting basic needs, these grants reflect the diverse ways organizations are serving their communities," said Frank Miley, co-CEO and trustee, OBT. "We are honored to continue Otto Bremer's mission by supporting this vital work."

State totals for grants awarded include:

- Minnesota: \$11,775,000
- Montana: \$1,700,000
- North Dakota: \$570,000
- Wisconsin: \$3,370,000
